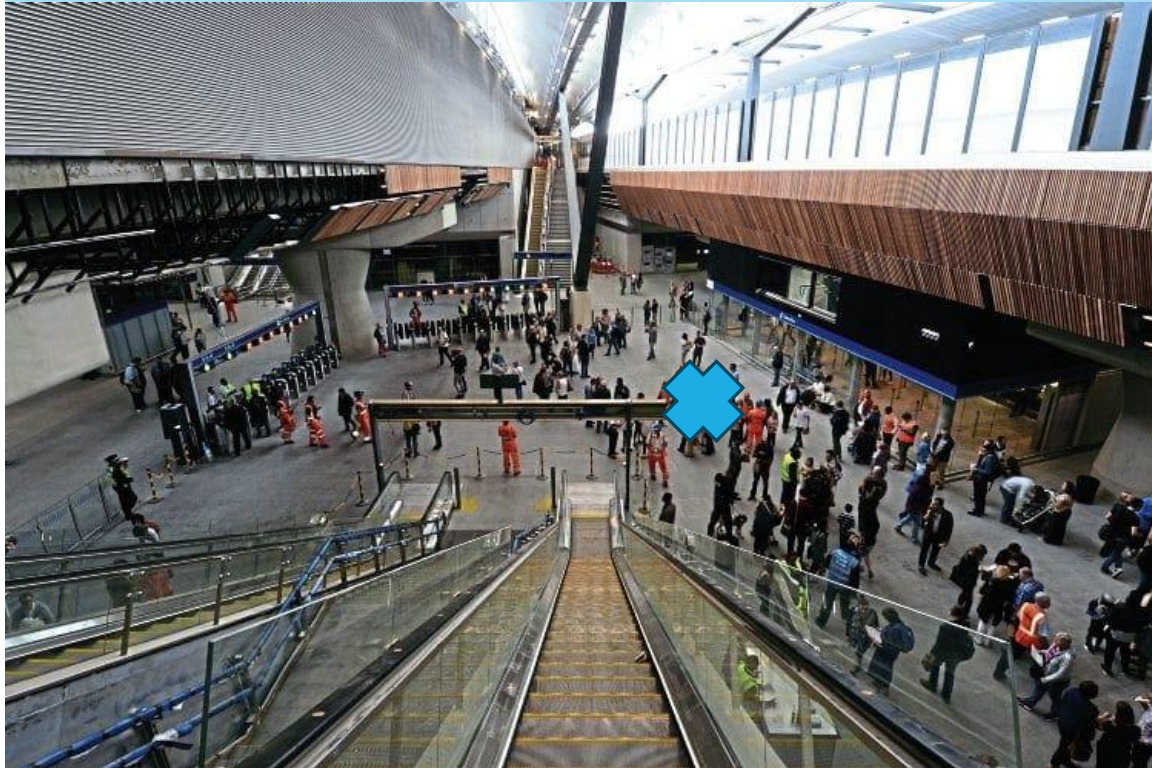
Feel free to track the flights using the flight number and locator. This will be important in order to gauge an ETA on arrival back to school.

# ITINERARY- DAY ONE

# ITINERARY DAY TWO

Arrive for a confirmed visit to **Hellisheidi Power Station**. Here the group will see a film about geothermal power and the development of the power plant. There is also the opportunity to view the turbine area from a viewing platform.

## Kerid

The Kerið crater is an almost perfect miniature volcano and northern most of a row of spatter cone formed by an eruption 3000 years ago. There is a lake within the crater whose level changes with fluctuations in the water table. A fee of 500 ISK per person is payable on arrival.

## Gullfoss waterfall

One of the most impressive waterfalls in Europe which is approached along the rim of a 2.5 km canyon where students can observe a classic example of waterfall formation caused by a resistant basalt cap rock. There is a gift shop and public toilet here.

## Great Geysir

You will see one of the most active geysers in the area, Strokkur, spouting up to 25 metres every 5-7 minutes. Nearby there is a café and gift shop.

## Pingvellir National Park

A beautiful canyon running through the park forms the meeting point of two of the earth's tectonic plates and a unique opportunity to witness the mid-Atlantic ridge. A visitors' centre with multimedia exhibits and a gift shop can be found here.

# ITINERARY DAY THREE

**Skógafoss waterfall**, which is more than 200 ft high. There are steps leading up to the top of the waterfall, however, I would advise against allowing the students the climb these, as there are subsidiary paths at the top which lead to grassy terraces and unguarded edges. In addition to this, the steps and path are often icy during the winter.

**Reynishverfi**, a black sand beach with views of sea stacks and Dyrolaey, a peninsular with a good example of an arch. There is a coffee shop with toilets nearby.

**Sólheimajökull**, a glacier tongue that lies south of the Mýrdalsjökull Glacier. The glacier tongue will be viewed from the car park; it is not currently possible to get close to the glacier. Groups are advised not to approach or climb onto the glacier unless accompanied by an experienced mountain guide.

**Please note:** The visit to Sólheimajökull is weather and time dependent.

**Seljalandsfoss waterfall.** If the path is free of ice it may possible to walk behind the falls- waterproof clothing is essential. There are public toilets here.



# ITINERARY DAY FOUR

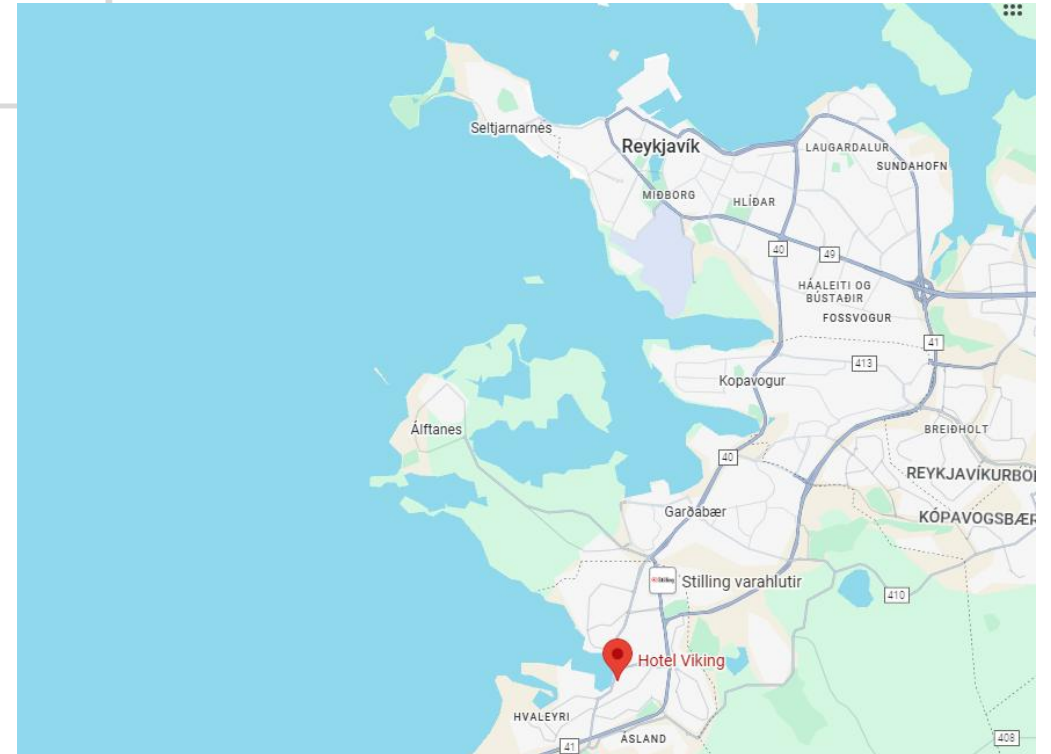
## Day 4: Sunday, 15 February 2026

## Confirmation of Risk Protection Arrangement (RPA) Overseas Travel

# **GLOBAL HEALTH INSURANCE CARD**

EHIC: Current European Health Insurance Cards (EHIC) are valid as long as they are in date. When your EHIC has expired you need to apply for a new **Global Health Insurance Card (GHIC)**. The new GHIC card is **free** to obtain from the official website and should be **applied for at least 4 weeks before travel**:

Both cards will offer equivalent protection for emergency and medically necessary healthcare needs when in the EU on holiday.



# PASSPORT

- A valid passport is required.
- The travel company requires travellers to have a passport expiry date of at least 6 months after the day we leave, which means they must have an expiry **date any time after 12<sup>th</sup> August 2026**. 3 months is the absolute minimum (12th May 2026)
- If you do not hold a UK passport, you are responsible for applying for any visas required.
- It is absolutely the parents' responsibility to ensure their child can travel to Iceland and neither the school or travel company accepts any liability if anyone is refused.

# WHAT TO BRING

- One large suitcase (**Max. 15kg** – not a lot) and **one** carry on (45 x 36 x 20cm) which must fit under your seat. Correct at time of publishing but you must check Easyjet before travel.
- Toiletries
- Very warm and waterproof jacket and trousers
- Long sleeve tops, including thermals
- Hat and gloves
- Comfortable, waterproof shoes (walking shoes ideally)
- Swimwear
- Bath towel \*Optional
- Pyjamas
- Water bottle
- Snacks (in suitcase)
- Leisure wear
- Plastic bag for dirty clothes
- Money for snacks and souvenirs (optional)- most places accept card- please exchange any money before you go to the airport- ICELANDIC KRONA
- Books/games for free time (optional)
- Phone charger and two-pin plug adapter



# **SAFETY AND BEHAVIOR**

Keeping safe whilst we are away is very important. Therefore, each child will be given a “I’m lost” card to carry on their person whenever we are on outdoor activities. The card will be in a booklet that will consist of accommodation details and a number to call the trip leader.

While we are away, please remember your child’s behaviour represents our school. Therefore, your child is expected to conduct themselves appropriately and have respect for both staff and their peers. We want everyone to have an enjoyable experience. This goes for students 18+, we have a duty of care to ensure their safety.
